Amanda's Dance Express L.L.C. ("ADX") accepts cash, personal checks, money orders, debit cards, Visa and Master Card. Please make checks payable to Amanda's Dance Express L.L.C. Please label your payment with your child's name. **ADX reserves the right to terminate enrollment, without refund, for violation of policies herein.**

Tuition Policy

- ◆ **Lessons are payable in advance of the start of the summer session.** The session rate is calculated based on 6 weeks of instruction during our summer session June 6-July 18, 2009. ADX collects tuition in one installment. ADX will only bill if your account is past due. **After June 11th, a \$25 late fee will be charged to outstanding accounts.**
- ◆ A current enrollment form must be signed, dated and on file in the office before any student can take class. A registration fee of \$25 per student or \$40 per family is due with the session fee for your child to be considered for enrollment.
- ◆ **There will be no refunds for the summer session.**
- ◆ A NSF fee of \$40 will be added to checks that are returned to us not paid. Please contact the office to settle your account and to pick-up your check. **To avoid bank charges, we do not redeposit returned checks.**

Dress Policy

- ◆ Our dress code was formulated with a sense of purpose to promote the proper attitude and respect for all dance disciplines. Please review our dress policy before purchasing new attire and shoes. **Dancers not in the proper attire with their hair secured will be asked to observe class.**
- ◆ Jewelry that is worn to class will be taken up.
- ◆ Gum-chewing is not allowed.
- ◆ Please label shoes and other related items with your dancer's first and last name.

Concert Policy

- ◆ ADX agrees to provide a place for your dancer to perform in our annual concert. Tumbling students are not concert participants.
- ◆ A \$60 (\$75 for Performing Company Dancers) concert fee is due on September 19, 2009 and a costume fee is due on December 5, 2009. Costume billing will be sent home with your child the first of September. A costume installment plan is offered September-November. Costumes will not be ordered for dancers, whose account is not up to date. After the 3rd of each month, a \$20 late fee will be charged to outstanding accounts.
- ◆ In order for your child to participate in the annual concert, your account must be cleared on or before May 1, 2010. This includes past due tuition, late fees, costume, concert and any other fees incurred. Dress rehearsal attendance for our annual concert is mandatory.
- ◆ ADX does not allow refund for concert, costume, competition or convention fees.

Studio Policies

- ◆ Should the GPISD close due to inclement weather, the studio will also close. Missed classes in excess of one per school year will be rescheduled.
- ◆ Since the programs of the studio are progressive, it is important that students arrive promptly and regularly for the classes in which they are enrolled. ADX does not allow for make-up classes. Students that do not have regular attendance will be required to attend and pay for private lessons.
- ◆ Students must be enrolled prior to September 5th of the 2009-2010 dance year in order for the year to be counted towards their award year. Enrollment after September 5th of any given year resets your dancer's dance year total back to one.
- ◆ Do not bring candy, food or drinks into the studio(s) or lobby.
- ◆ ADX reserves the right to cancel or modify any class not maintaining required enrollment.
- ◆ Dancers and their parents give permission to Amanda's Dance Express L.L.C. to use their photographs and/or videos in connection with advertising and television broadcasts.
- ◆ ADX reserves the right to limit any child to the skills that can be safely performed to his or her level or experience.
- ◆ **Vacant dance rooms are not available for play.** Non-dancing siblings should be supervised at all times. (No running in the lobby, standing on the furniture, etc.)
- ◆ Class viewing from our studio lobby is welcome as long as the classes are not being distracted by the lobby noise and activity. Please do not tap on the windows.
- ◆ Should the lobby traffic overrun the dancers it is established for, the lobby will be closed and drop-off and pick-up of all dancers will be enforced.
- ◆ Your account may be placed into collection status if you fail to pay your account in a timely manner. You will be responsible for all attorney's fees, court costs, agency commissions, and other assessments incurred by ADX to collect your unpaid account balance.
- ◆ Parents and students are to demonstrate courtesy and respect to ADX staff, fellow parents and students and behave in a responsible manner at all times.
